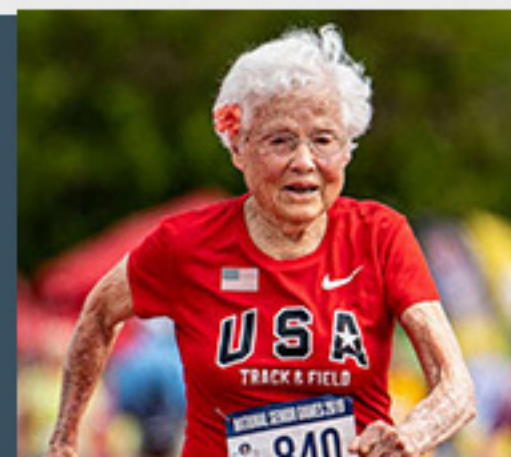


### Which Party Has To Pay Spousal Support Or Alimony In A Divorce?
